If a 12 year old or younger contestant is enters a 13 year old or older division, choking techniques will be allowed.4. Kansetsu Waza (Joint lock techniques) will be allowed in the Black/Brown Belt division only.5. Waki Gatame and Juji Gatame flying armlock will not be allowed from a standing position.6. If there is a tie at the end of the Golden Score period, the Mat Supervisor and Center Referee will determine the winner.7. The CARE System will not be used.8. Contest areas will be 6m x 6m plus a 3m safety area with 4m between adjoined contest area.		
AWARDS:	Each pool will be awarded first, second and third places.
