## **1.Information and Instructions**

Refer to Jujitsu Rank Examiner Certification Program Guidelines available on USJA website. Initial certification will be at National level regardless of rank Candidate must have current rank of Yodan or higher when applying for NCRE.Candidate must have rank of Rokudan or higher when applying for MCRE. Candidate must have current background check, SafeSport and Heads Up certification. NOTE: If required background check or SafeSport certification lapses for more than 60 days, Certification is revoked and you must reapply.
