Section 2: Certified Rank Examiner (CRE) Levels

- Certified Rank Examiner (CRE) 3rd Dan
- Regional Certified Rank Examiner (RCRE) 4th Dan
- National Certified Rank Examiner (NCRE) 5th Dan
- Master Certified Rank Examiner (MCRE) 6th Dan or higher

Section 3: USJA CRE Procedures

- Once someone reaches the rank of 3rd Dan, they are eligible to become a USJA Certified Rank Examiner (CRE).
- All levels require that they show understanding and ability to apply all the promotion procedures, test the applicant, and review a Recommendation for Promotion (RFP) and Activity Log/Summary Sheet.
- This program allows individuals meeting the requirements to examine others for rank promotions.

For New Applications:

• As a *new* CRE or RCRE please attach one typed and completed Shodan Promotion packet. As a *new* NCRE or MCRE please attach one Yodan or above Promotion packet. This can be an actual tested or verified applicant or a sample that demonstrates understanding of the USJA Judo Rank Promotion System.

Sign Off Authorization:

All blackbelt promotions, Nidan and above, must be signed off by the appropriate level Certified Rank Examiner.

- **CRE**: Must have a minimum rank 3rd Dan. As a CRE, you are allowed to recommend promotions for up to one rank below yours. These promotions will all be reviewed and signed off by the Promotion Board.
- RCRE: Must have a minimum rank or 4th Dan. As a RCRE, you are allowed to recommend promotions for up to one rank below yours. These promotions will all be reviewed and signed off by the Promotion Board.
- **NCR**E: Must have a minimum rank 5th Dan. As a NCRE, you are allowed to recommend promotions up to one rank below yours. These promotions will all be reviewed and signed off by the Promotion Board.
- MCRE: Must have a minimum rank 6th Dan. As a MCRE, you are allowed to recommend promotions up to your current rank. These promotions will all be reviewed and signed off by the Promotion Board.

- To remain a valid CRE, all rank examiners must maintain USJA membership, current Background Screening (BGS), SafeSport and Concussion Training certifications. All CRE must renew every four years.
- **NOTE:** When a blackbelt is promoted to the next higher level in rank, they automatically are transitioned to the next level of CRE. Once you are eligible to be a CRE and again when you are eligible to be a NCRE or above, you must attend a Zoom clinic.
- It is strictly prohibited for a CRE or anyone, including a coach or sensei, to sign off anyone they do not examine, witness the testing and verify the promotion documentation; this is considered an ethical violation.

- As a Certified Rank Examiner, I agree to follow the <u>USJA Judo Rank Promotion System</u>.
- I will personally examine, witness and/or verify all required documents to support an applicant's request for promotion.
- I understand that signing off anyone who does not meet all requirements is an ethical violation and could result in losing Certified Rank Examiner privileges for the USJA.
